

## **ENVIRONMENT and OUALITY POLICY**

Founded in 1947 Grimaldi Group Naples is today the leader in maritime transport of passengers, cars and other rolling cargo (ro/ro), with one of the main world roro/multipurpose and car carrier fleet. The Group also transports goods in container and palletized cargo, on all served routes.

In this process, the implementation and certification of Quality and Environment systems have been a strategic choice by the President decisive for Grimaldi Group Naples improvement and increased competition. In fact, the certificates got in compliance with UNI EN ISO 9001 and 14001, allowed Grimaldi Group Naples to face the market with a deep competitive advantage as better organised and able to "satisfy" customer's needs and correctly orientate themselves in relation to environmental requirements.

Seen the extensive experience, the President of Grimaldi Group Naples considers worth continuing in this direction. In order to keep his commitment for a constant improvement in Environment and Quality areas he decided to integrate both systems, considering this as a good opportunity for the constant performance improvement.

The implementation of ISO 9001 and 14001 of 2015 edition, represents a very important moment for further consolidation of the adopted Systems. In this perspective, an integrated quality/environment management system can consolidate better the competitive advantage of the group on the market.

Each person, or Company organisational unit, must have a role active and aware to pursue this objective. For this not only has to comprehend and implement the company's policy aimed at achieve it, but also actively support it. Therefore, it has to be always clear that the Company's success depends on the awareness and an aptitude to operate at the "client's service", both external and internal in view of respecting the environment and pollution prevention

  - To control all processes that influence the product and the related environmental aspects;
- To comply with all indications and obligations arising from regulations, environmental laws and other commitments undertaken by Grimaldi Group Napoli related to environmental safeguard, for all activities both on board and ashore;
- To prevent pollution, by reducing where possible discharge, waste, and use of resources, by regularly and systematically monitoring the environmental impact of the Group's activities, and by following all instructions aimed at preventing or eliminating pollution itself;
  - To work out targets of continuous improvement of the environmental performances;
- To use technology that provides the best technical and economic performance with the lowest environmental impact;
- To assess the environmental aspects of products and activities and adopt management procedures that minimise any significant impact on the environment; the environmental impact of new services or activities will be previously assessed;
- To train all personnel, at every level, in order to promote and encourage every activities aimed at protecting the environment, through raising awareness and promoting cooperation. This way, the skills and efficiency of personnel both on board and ashore are continuously improved;
- To avoid or restrict sea pollution in case of an accident, through continuous training to personnel about the instructions and emergency plans established by the Grimaldi Group Naples for its Companies;
- To raise awareness among suppliers about the environmental management of the activities relevant for the Grimaldi Group Naples, and to induce suppliers to adopt an environmental and quality management system themselves;
  - To communicate with, and involve, all those concerned.
  - Adopt all the possible countermeasures and strategies to avoid threats/incidents in terms of cybersecurity



• ensure timely, efficient and transparent communication with the Public Administration, especially in relation to the commitments made with the public service concession award.

To ensure respect of the above-mentioned principles, the following has been arranged

- Appoint the Environmental and Quality Manager (EQM);
- Create an effective system of internal communication, in order to bring personnel up to date, raise awareness and accept suggestions;
- Create a company structure allowing for environmental procedures to be applied in a suitable and effective way;
  - Review periodically its environmental objectives and targets.

The Integrated Environment and Quality Management System adopted, understood and shared by all personnel, properly and accurately applied, shows, through documentation, the Grimaldi Group Naples President's ability to ameliorate and keep on environmental and quality preservation requirements as promised. This will contribute to increase Company's profits and will improve Company's world market imagine.
